On June 6, 2022, I, Detective Eric Gould #386, was assigned to investigate an incident that occurred on Saturday June 4, 2022 at the Dancing for the Space Coast Fundraiser. The fundraiser was held at the Florida Institute of Technology Clemente Center, located at 3011 Panther Place, Melbourne, Brevard County, Florida.

I was made aware that Republican House Representative Randall Fine had filed a complaint with the Melbourne Police Department that he was accosted by City of Palm Bay Deputy Mayor Kenneth Johnson II during this event.

On June 8, 2022, I conducted a sworn audio recorded interview with Mr. Fine at his office, 2539 Palm Bay Road. During this interview, Mr. Fine advised that he was standing by his table speaking with two other guests of the fundraiser. While speaking with these guests, Mr. Fine stated that he was approached by Mr. Johnson and another unknown black male. Mr. Fine described that Mr. Johnson came up to him in a manner that would be considered unprofessional by invading his personal space, angrily staring at him, and interrupting his conversation. Mr. Johnson was accosting him with what Mr. Fine considered to be vague open ended threats. These vague / open threats included the statements, "You better stop it or else. You'll be sorry." Mr. Fine advised it became so confrontational that the other two individuals left.

During the argument, Mr. Fine advised that he told Mr. Johnson to get away from him. Stating something to the effect of "Get away from me you thug." Mr. Fine advised that he then turned and walked away from his own table to avoid any further confrontation with Mr. Johnson at this charitable event. Mr. Johnson pursued Mr. Fine and re-engaged him in the argument. Mr. Fine advised that the argument continued until a guest, identified as Melinda Gibson (Mindy Gibson) of Satellite Beach City Council, intervened and was able to separate Mr. Johnson from Mr. Fine.

Mr. Fine identified that there is "history" between him and Mr. Johnson and none of it is good. Mr. Fine advised that this is not the first time Mr. Johnson and him have been engaged in arguments like this. Mr. Fine doesn't know why Mr. Johnson did this at this event but believes it is possible retaliation for Mr. Fine publically displaying Mr. Johnson's criminal history, specifically the 2015 case of alleged sexual misconduct, and arrest of Mr. Johnson. Mr. Fine advised that he was not specifically scared of Mr. Johnson, but was in fear of what Mr. Johnson may do. Mr. Fine expressed his fear and concern that if Mr. Johnson was brazen enough to do this at the fundraiser would he may target him or his family.

On June 9, 2022, I conducted a sworn audio recorded interview with Mrs. Gibson at Satellite Beach City Hall, 565 Cassia Boulevard. Mrs. Gibson advised that during the fundraiser she noticed Mr. Fine and Mr. Johnson on the dance floor face to face about a foot apart. Mrs. Gibson advised that she felt this was not good because of the history between the two gentlemen. Mrs. Gibson identified that there was tension in the air between the two. Mrs. Gibson intervened by approaching the two and placing her hand on each of their shoulders. Mrs. Gibson advised she said something to effect of "Gentlemen the Sheriff asked us to take our seats, dinner is about to be served." Mrs. Gibson advised that the two glared at each other for a few moments until Mr. Fine turned and walked away. Mrs. Gibson advised she walked away with Mr. Johnson as the two were headed in the same direction back to her table. Mrs. Gibson advised that Mr. Johnson stated, "I wasn't going to hit him."

On June 8, 2022, I contacted FIT security, specifically Jack Gordon, and inquired if there was any security cameras in the area that may have captured the incident. June 9, 2022, Mr. Gordon contacted me back and advised he located the incident on film and it was ultimately uploaded to evidence.com.

I reviewed the video surveillance footage and observed the following:

#### **Narrative**

On June 4, 2022, at approximately 6:20 p.m., Mr. Fine is standing at his table, which is located in the front middle closest to the dance floor, speaking with two other guests of the fundraiser. At approximately 6:21 pm you see Mr. Johnson and an unknown black male approach Mr. Fine and the other two guests. Mr. Johnson walks directly up into the group of three gets within, what appeared to be, less than a foot of Mr. Fine. The unknown black male walks around the group and hovers behind Mr. Fine. It appears Mr. Johnson interrupted the conversation judging by how the other two guests quickly exited the conversation and immediate area.

The video shows Mr. Johnson and Mr. Fine standing face to face engaging in a conversation while the unknown black male hovers to the side. At approximately 6:23 p.m. Mr. Fine turns and walks away from Mr. Johnson. Mr. Johnson pursues Mr. Fine and re-engages him. The conversation continues until approximately 6:26 p.m. when you observe Mrs. Gibson walk up to both gentlemen and intervene. Mr. Fine and Mr. Johnson part ways.

On June 10, 2022, I contacted Palm Bay City Hall at phone number 321-952-3400. I was directed to the secretary who advised that Mr. Johnson had left the office for the day. I left my contact information and advised that this was in reference to the incident that occurred between Mr. Johnson and Mr. Fine Saturday night at the fundraiser. I was also provided Mr. Johnson's cell phone number of 321-474-0183. I was directed to voice mail and I left a message identifying myself, contact information, and purpose for the call. As of June 14, 2022, I have not heard back from Mr. Johnson to obtain a statement.

This case is currently active. Attempts to contact Mr. Johnson are ongoing.
