Palm Beach County Republican Executive Committee ([palmbeach.gop](http://palmbeach.gop)) meets on Wednesday, December 14, 2022 at 6:45pm at the Palm Beach Airport Hilton to elect new officers: Chairman, Vice Chairman, Secretary & Treasurer to serve as a volunteer officer, for a four-year term.

We call for Chairman Michael Barnett (and all officers who have completed two terms) to gracefully step down after serving 8+ years, to

provide 2021 & 2022 financial audit details (as required in bylaws) and to allow fair elections to take place without interference in December.

At the October 2022 REC meeting, Chairman Barnett's actions caused distrust & a lack of credibility as members watched in disbelief as Barnett intentionally blocked 22 new members from joining the REC & used trickery to prevent a vote for a November meeting that the majority of members requested via signed petitions.

We encourage all 300+ Palm Beach REC members to attend the Dec 14, 22 meeting and remain for the entire duration to ensure that a quorum is established and that each vote counts.

### **PROBLEM**

We believe the current Republican Party of Palm Beach County is a microcosm of what needs changed in America- RULES FOR THEE, NOT for WE!

In 2022, over a hundred new members joined the REC to make positive changes in Palm Beach County politics as recommended by Steve Bannon— War Room PRECINCT STRATEGY.

New REC members expressed that they did not feel welcome or engaged in meaningful activities. They observed a “select few power players,” regurgitating an RPOF guided narrative who dominated and controlled the organization with a lack of emphasis on fixing the 2020 election.

Many members expressed an urgent need for a “change of the guard “ at the Palm Beach REC, providing feedback that they have antiquated procedures, are “out of touch” and refuse help. Board members have publicly denied that the 2020 election was stolen, and yet those same officers control a popular political club that makes money off of promoting President Trump to REC members.

At the October 2022 meeting, we witnessed “trickery” by Chairman Barnett intentionally blocking other members from joining the REC and watched him prevent a vote for a November meeting in order to stop members from running for board positions when it was obvious that the majority of members were in favor of a meeting. The decision was justified by stating “we have NEVER had a November meeting in the past”. Of course not - they don’t want to change and will not relinquish power!

### **MEMBERS HAVE NO INFO ON IMPORTANT DECISIONS.**

REC officers Do NOT disclose to the members the actions taken at ANY monthly board meeting!

Who makes the decisions on the office staff salaries, how the candidates donations will be distributed, how much RP PBC money is donated to RPOF each year?

We have seen basic parts of the REC budget but a detailed audit is not easily accessible for member viewing.

At quick glance, the basic financials prove that the current board has not spent money wisely, has not asked for REC members to pre-approve budget items.

**Palm Beach REC has NOT supported many grassroots *America First* candidates, instead Jane Pike, Treasurer, approved campaign donations “above legal limits” to financially back “establishment” candidates quietly, directly and indirectly through donating to political PACs.**

The REC does not need to legally file reports to the Florida Election Commission- WHY NOT?

Both seasoned and new Palm Beach REC Members have complained of it being a “good old boys club.”

Members are not properly trained, mentored or informed of meaningful volunteer opportunities.

**There was NO MASTER PLAN to Coordinate Volunteers & Place Candidate Signs at PBC Polling Locations for Mid Term Elections.**

- DeSantis/Rubio campaign signs placed without considering placing lower ballot candidates for both election day & early voting.
- Lower ballot candidates volunteers were left completely on their own!
- Hundreds of signs left at PBC REC HQ Friday & over the weekend. Hundreds of DeSantis signs were unused and sitting in boxes instead of being placed at Election polling sites.
- 18 of the 23 early voting sites had NO GOP volunteers handing out pick lists & waving signs.
- Dems had paid operatives at almost every site!
- 2 REC campaign offices in minority precincts in Pahokee & 45th Street were NEVER open!

WHAT A WASTE OF MONEY!

Many REC members have stated that the monthly meetings are long, boring & unproductive. Their agenda includes proposed inappropriate resolutions asking members to financially support Ukraine rather than America First candidates. SAD!

REC members have complained that the events are expensive and the same “select few members” get volunteer opportunities for Maralago and Trump events. They have asked for more opportunities to meet at lower price points, such as new member luncheons and informal meet & greet events that don’t cost hundreds of dollars.

**SOLUTION**

There is a “changing of the old guards” taking place in America, and it is happening locally in Palm Beach County, Florida!

The initial task of the new elected board will be to review and recommend updated practices, procedures, and principles in the Bylaws to include Term Limits for all board seats, as per membership approval- ensuring agenda items are voted on in a timely manner—WITH QUORUM!
